With live events cancelled all around the world during the Covid pandemic, the Age Friendly Ireland shared service, hosted by Meath County Council, is thrilled to announce that we are back and looking forward to our first live awards event since 2019. Each year a local authority hosts the awards and we are excited to reveal that Clare County Council are hosting the National Age Friendly Recognition and Achievement Awards for 2022 on 27th October in Dromoland Castle, County Clare.

The primary aim of these awards is to recognise and reward achievement in age friendly initiatives around Ireland. We are calling for organisations, individuals/members of the public, agencies and communities to submit applications on projects or programmes that they consider to be age friendly, especially those initiatives that have supported older people throughout the pandemic.

This year, eight categories of awards, aligning to the WHO themes, have been chosen as they have a meaningful impact on the lives of older people in Ireland – Age Friendly Transport, Active & Healthy Ageing, Business Innovation, Safety & Security, Communication, Community Innovation, Environment, Housing.

Supports for 'Ageing in Place' - Minister Burke Hears Participant Experiences on a New Local Government Programme

Minister Peter Burke today visited Westmeath County Council to hear about a new co-ordination service that is supporting older people to remain living at home independently. The **Healthy Age Friendly Homes Programme** is delivered by local government via the Age Friendly Ireland shared service. It is funded by Sláintecare in the Department of Health, aligning with the health reform programme's mission to provide early intervention and community-based supports.

Under the programme, local co-ordinators visit older people in their homes and help them to access grants and other supports in the areas of housing, health, community services and assistive living technology.

Phase 1 of the programme is operational in nine local authority sites around the country (Dublin City, South Dublin, Fingal, Tipperary, Cork County, Longford, Westmeath, Galway and Limerick). Local coordinators develop integrated support plans to enable the older person to remain living independently. The aim is to:

- Improve their housing conditions, for example through adaptations, rightsizing, homesharing, and energy retrofits
- Support overall health and wellbeing through improving access to social, community, transport and technology supports
- Prevent falls and reduce admission to acute settings or residential care
- Reduce the average length of stay [AvLOS] in acute settings by ensuring that the home environment is suitable for discharge from hospital



Minister Burke has described the programme as "a very welcome development in the context of housing for our ageing population. The government's stated ambition - and mine as Minister with responsibility for housing for older people, is to support older people to live with dignity, to have choice in housing and to have the best possible quality of life in older age. The Healthy Age Friendly Homes Programme is an early intervention that provides direct support to an older person in their home to enable them to continue living independently."

One of the programme participants Geraldine Murphy, who spoke at a recent Sláintecare webinar, described how the local co-ordinator assisted her: "When the co-ordinator visited me, together we went through what was available to me. We filled in the forms for the personal alarm, in case I fell; I felt a bit safer having that. From that then I applied to the Council for the stairlift application and also for the bathroom. I was very grateful to find out that that was available."







This new programme, established in 2021, is already demonstrating significant results. By mid-April 2022, the programme had carried out **1,266** assessment visits, with **2,476 actions** in progress. One of the main areas of need is for housing adaptation grants. Home adaptations can lead to positive outcomes for the older person, such as a safer, more accessible living environment, reducing the risks of falls and improving warmth and comfort in the home.

The programme evaluation is being undertaken by Maynooth University. The interim evaluation report has identified that many participants experience significant difficulty with activities of daily living [ADLs] such as climbing stairs, walking short distances and standing for long periods. On entry to the programme, 28% of participants reported difficulty using the stairs all of the time; 23% reported difficult with shopping/getting out all of the time, and a further 20% report difficulty sometimes. 21% reported difficulty with bathing or showering all of the time, which suggests that many are living in housing without accessible bathroom facilities. This is a key area that the programme can support through adaptations or rightsizing.

Minister Burke met with the Leas Cathaoirleach of Westmeath County Council Cllr Bill Collentine, local Healthy Age Friendly Homes Co-ordinators Ann Moran and Mary Carey, programme participants, and local authority staff.



Plans are in progress to scale up to Phase 2 with the intention of covering all local authority areas. Chief Officer of Age Friendly Ireland, Catherine McGuigan commented: "We believe that local government is best placed to deliver this bespoke service to older people in our communities, as there are direct linkages into local authority housing and community departments. Scaling up this programme to all of Ireland will be one of the most significant ways we can prepare for population ageing and realise the Programme for Government's vision of an Age Friendly Ireland. The programme represents a systemic change in providing support at a very early stage and helping older people to future proof their living environments. This will reduce demand for public spending in acute health care and residential care."







Opportunity to Participate | Irish Independent Article



The European population is ageing. By 2040, 155 million people are expected to be over 65. This demographic change means, for the first time, four generations share a longer lifespan together. This evolution is often referred to as a challenge, but this ignores the considerable benefits that society can gain from an experienced, active, and engaged third generation. Above all else, this group can play an important role in building greater intergenerational cohesion.

As we emerge from the pandemic, does intergenerational conflict still exist and how has this been impacted after the last two years? What role does the senior population play in society? What can we do to enhance intergenerational cohesion?

Cycle Without Age Ireland Summer 2022 Update



Fifty Trishaws in 5 Years: We now have 50, *yes, fifty*, trishaws in different parts of Ireland. The initial intake of trishaws was to care homes, but more recently the uptake is from local authorities. To date, the following Councils though their Local Sports Partnerships have purchased multiple trishaws for community use:

Pouncil has two, with part sponsorship from corporate Canada Life Reinsurance. These operate in the Bike Hub, www.thebikehub.ie, a social enterprise supported by DLR Council where they also have other inclusive bikes: two trikes, for adults and for children, a handcycle and a tandem. Many of our new passengers are service users from St. John of God Services and Enable Ireland. The trishaws give them a real sense of inclusion, fun and enjoyment in the great outdoors. Since we started in DLR last July, our pilots have taken out over 260 trishaw rides. DLR Council just released this great video of the service. See the value of inclusive cycling! Please feel free to share these short videos to tell the story of CWA.

- Fingal Council has three, which serve the communities in St. Catherine's Park Lucan, at Skerries, and Baldoyle to Portmarnock.
- Dublin City Council has five, which will operate from the War Memorial Gardens at Islandbridge, and at Eamonn Ceannt Park in Crumlin.
- > Tipperary Council has three, which are going to Cahir, Clonmel and Roscrea.

Community Safety Innovation Fund

On behalf of the Department of Justice we would like to draw your attention to the funding call for the **Community Safety Innovation Fund (CSIF)** recently launched by Minister McEntee.

A fund of $\[\in \]$ 2 million has been made available for 2022 to support the development of community safety through innovative, local community-based initiatives. The fund, which is financed by the Criminal Assets Bureau, will ensure the seized proceeds of crime are utilised to support community safety. Grants will be in the range of $\[\in \]$ 20,000 - $\[\in \]$ 150,000 and the closing date for applications is 8 June 2022.

We would ask that you bring the fund to the attention of any initiatives in the area that you deem appropriate.

Initiatives could include activities intended to:

- tackle crime or reduce the fear of crime; improve community safety and feelings of safety
- support the creation of safe and resilient communities;
- reduce reoffending;
- divert vulnerable individuals away from engagement in criminal behaviour.

Applications are invited from community safety initiatives as well as groups cofunded with local authorities, NGOs and community organisations working on issues relevant to community safety and youth justice. Applications may be submitted by individual organisations, or by a consortium involving two or more organisations where the lead partner is a community organisation, not-





for-profit, social enterprise or similar with a remit relevant to community safety and/or youth justice. Applications with innovative approaches to be especially considered.

Minister Mary Butler launches Wexford Age Friendly Strategy 2022-2026

Wexford County Council has launched its 2nd Age Friendly Strategy and Action Plan, for 2022 to 2026 which will enable the Council and its Age Friendly partners to make the county a better place to live and grow older in. Speakers at the event included Cathaoirleach Cllr Barbara-Anne Murphy, Chief Executive of Wexford County Council Mr Tom Enright, Wexford OPC Chair Kevin Molloy, Dr. Yvonne Byrne (report author) and Alice Corbett, Age Friendly Ireland, with Minister Mary Butler officially launching the strategy. Minister James Browne and Senator Malcolm Byrne and members of Wexford Older Peoples Council and Age Friendly Alliance were amongst the invited audience.







In launching the strategy Minister Butler said: "The current Programme for Government outlines a vision of an Age Friendly Ireland and documents policy approaches to supporting older people. Strategies such as Sláintecare, The National Positive Ageing Strategy, and Healthy Ireland, are hugely significant in how we prepare for, and support, an ageing population. At a national level, both myself and the Department of Health are very aware of Wexford County Councils efforts with helping to develop and deliver local Age Friendly Strategies. This feeds into our national policy frameworks to ensure that the voice of older people is included and referenced in decisions we make. Wexford County Council Age Friendly Strategy is a vital resource."



Wexford County Council's Age Friendly Programme Manager, Ann Marie Laffan, who acted as MC for the launch and has responsibility for managing the Wexford Age Friendly Programme thanked all those who contributed to the strategy, in particular the Age Friendly Alliance and Wexford Older Peoples Council members many of whom were in attendance at the launch. She added that she is looking forward to working with all involved to implement the new strategy and the actions contained therein.

This is a wonderful testament to how we value and respect our ageing population across the country. Since its inception Age-Friendly Ireland, a shared service of local government, hosted by Meath County Council has worked not only to champion the needs of older people, but to educate and inform the wider population on the pressing need to adjust our environment and our attitudes to cater for a hugely growing demographic.

As part of this national programme the opportunity has been identified for each local programme area, hosted by each local authority, to have their own Age-Friendly Ambassador and Dún Laoghaire-Rathdown are delighted to announce Ronnie Delany as our Age-Friendly Ambassador for dlr.
