We know that creating an enjoyable and accessible experience for older consumers pays dividends for small and large businesses and the wider community. This category acknowledges age aware businesses which are innovative in their approach, and which recognise that older people as both producers and consumers bring a wealth of experience and expertise to our society. We particularly welcome entries from collaborative projects where business and the community came together to effect change.
