### **Foreword**

Leitrim is a county, which can boast world class natural attributes, with its mountains, lakes and waterways offering an outstanding natural environment and quality of life for its population. It has many social attributes to match its natural assets. It has a strong cultural heritage as well as diverse and active communities where, thankfully, significant numbers of local people still give their time voluntarily to improve the quality of life for themselves, their families and their neighbours. This commitment to strive to make things better is a social asset that we have tried to harness in developing



this initiative and strategy. Put simply, we are trying to make Leitrim an even better place to live, so that it continues to be a county, which caters for the needs of all of its people, whatever their age. In particular, we are trying to ensure that older people are recognised as the valuable resource that they are. We are trying to support them in a practical way to ensure that their voices matter, that they are heard, particularly in relation to decisions about the services and developments that directly affect them, and that they will have ever greater opportunities to participate fully in the lives of their communities.

That is why I am delighted to present the Leitrim Age Friendly County Strategy to you on behalf of the County Leitrim Age Friendly Alliance. Formally established and launched in 2012, the Alliance is made up of senior people in public sector and other agencies, older people's representatives and other supporting organisations such as the Age Friendly Ireland. In developing an Age Friendly County Strategy for Leitrim it is our hope that the Initiative will increase the participation of older people in the social, economic and cultural life of Leitrim for everyone's benefit, improve the health and well being of older people in the county and show how services and supports for older people can be made more responsive, caring, professional and accessible through imaginative and cost effective multi-agency partnerships. Producing the strategy represents a significant step for everyone involved with the Initiative because it commits all of the partners to delivering on specific actions within a set timeframe.

These actions are additional to existing services and by using existing resources and working collaboratively it is envisaged that significant added value can be achieved, as long as existing levels of funding are maintained. In adapting this approach we are trying to provide a coherent and creative response to some critical demographic challenges facing the county. The 2011 census revealed that 15% of the population were aged over 65 and 33% of people in Leitrim were aged 50 or over. The census also showed that the national combined dependency ratio had increased from 45.8 in 2006 to 49.3 in 2011, and that County Leitrim has the highest dependency in the State at 57.3. Additionally it showed that Leitrim has the highest proportion nationally of persons aged 65 and over living alone.



A more than twofold increase in the number of people aged 65 and over living in Ireland, is projected by 2041. As a county, we want to be prepared for these changes. We see it as an opportunity to build more inclusive communities, where the participation of older people is encouraged and underpinned by responsive and integrated service delivery. Being an Age Friendly County will mean that Leitrim will have accessible buildings and public realm, that its services support the full participation of older people in every aspect of social and communal life, that there is a positive attitude to ageing and that older people are valued for the potential contribution that they can make to their communities.

In producing this strategy, the partners are setting out their clear commitment to enhancing their effectiveness in meeting the needs and demands of older people. However, the strategy needs to be set against a wider context within the county. While aspiring for improvement and greater effectiveness in their service delivery, the partners are also mindful and acknowledge all of the excellent work carried out by a wide range of organisations that have and are continuing to deliver a range of benefits for older people. We look forward to that work continuing.

There are many obvious complementarities between what is already in place and what is planned through the delivery of this strategy. We are hopeful that by covering the eight themes of the World Health Organisation's programme and by having a strong interagency focus, that we can raise the bar in our collective efforts to create a county that is fully inclusive and where the participation and contribution of all of its people is recognised and valued. It is envisaged that the delivery of the strategy would create opportunities for further synergies and partnership working. Alliance members firmly hope that further partners would come on board through involvement in the Alliance itself, in its working groups or in support of efforts to achieve the targets that are outlined in the strategy.

Finally, I would like to acknowledge the work of all of the Alliance Partners and thank them for their effort and ongoing commitment. In particular, I would like to thank the staff members of the agencies who served on the Executive Committee for their hard work and commitment during the consultation and strategy development processes. I also wish to thank the older people, their advocates and support organisations, who took part in all aspects of the consultations that informed the development of the strategy, particularly the members of the twenty two Active Age groups and the Older People's Council. Their work and commitment has been central to what has been done so far and going forward they will ensure that we deliver on our aspirations to ensure that real improvements are made and that real benefits are delivered.

### Introduction and Background



This is the first Age Friendly Strategy for County Leitrim. It is a strategy that gives commitments to improving key areas of infrastructure, services, information, and our overall social response to older people's issues in Leitrim.

The strategy has been developed by the County Leitrim Age Friendly Alliance in consultation and co-operation with older people in County Leitrim. The Alliance was formally established and launched in 2012. It is made up of senior personnel in public sector and other agencies, older people's representatives and other organisations that promote a positive approach to ageing. Its members include:

- Leitrim County Council (County Manager)
- Leitrim County Council, Community, Cultural and Enterprise Development Strategic Policy Committee (Chair)
- Health Service Executive (Sligo Leitrim Area Manager)
- An Garda Siochána (Chief Superintendant for Sligo Leitrim Division)
- Mayo Sligo Leitrim Education Training Board (Chief Executive Officer)
- Leitrim County Enterprise Board (Chief Executive Officer)
- Irish Farmers Association (Regional Representative)
- Leitrim Development Company (Chief Executive Officer)
- National University of Ireland Galway (Professor of Gerontology)
- Leitrim Older People's Council (Chair and Vice Chair)
- Leitrim Citizens Information Service (Development Manager)
- Age Friendly Ireland (Age Friendly Regional Programme Manager)



<sup>&</sup>lt;sup>1</sup> Negotiations are at an advanced stage to set up Local Enterprise Offices (LEOs) in each county. These will be part of the Local Authority and will replace the County Enterprise Boards.

Each of the Alliance members has given commitments in this strategy that will significantly help to improve the quality of life of older people over the coming years. An Age Friendly county has been described by Age Friendly Ireland as a county that recognises the great diversity among older people and promotes their inclusion in all areas of community life. It is a county that respects their decisions and lifestyle choices and anticipates and responds to their needs and preferences.

### Our ambition to be Age Friendly means that Leitrim will:

- Become one of the best places to grow old in;
- Have easily accessible public buildings, shops and services;
- Incorporate older people's views into significant decisions being made about the county;
- Promote a positive attitude to ageing and address stereotypes about older people;
- Create opportunities for older people to engage with their county socially, as employees and as volunteers.

This is a far-reaching strategy with 23 new cross-cutting actions that will be delivered by more than 50 organisations over the three year period. Many of the actions will have a very tangible impact on the county, while others, such as those relating to awareness-raising work, will be more subtly felt.

### **Background and Consultation Process**

Prior to the establishment of the Leitrim Age Friendly Alliance, twenty-two Active Age groups operated in the county, organised into two networks in North and South Leitrim. These organisations offer opportunities for older people in the county to organise collectively, to deliver wideranging programmes of activities and to advocate on behalf of their members. Their members have been powerful advocates of the 'Age Friendly' message and the importance of the older person's voice in local developments. Both networks and all of the groups are supported by Leitrim Development Company and the HSE. The Active Age groups have provided valuable guidance, information and resource to the Alliance, particularly in the consultative stage of the strategy preparation process.

The research and consultation process included the following elements:

- Reference to the learning from previous key exercises such as An Saol Maith
- Structured discussions with 180 older people and their advocates
- A baseline questionnaire of 200 older people
- Focus groups with LGBT, Aras Brid, Ballinaglera Social Day Centre, the Christian Minorities Network, Travellers, Intercultural Group and Kinlough Active Age group
- One to one interviews with Alliance members to elicit Agency responses to the findings of and issues raised through the consultation process



As a result of this robust approach, a documented list of the issues faced by older people in the county now exists along with the creative suggestions for resolving these issues, which older people have provided. Interestingly the issues, themes and services that were identified as particular assets and strengths are also the areas in which participants would like to see further investment and enhancement of existing provision. The vibrancy and key role of Active Age groups was highlighted, as were Home Help and Day Centre provision and Rural Transport provision.



All of the issues highlighted in the consultation process and the suggestions of the older people regarding how these issues could be addressed were considered by the appropriate Alliance partner during the one to one interviews and Alliance follow up, and the Actions contained in the following section were developed by the Alliance partners in response to these. Because of the robustness of the process and the richness of the data, we are confident that this strategy is firmly evidence based.

### Why are we adopting an Age Friendly Strategy?

Statistics, both nationally and globally, tell us that populations are ageing as people are living longer, healthier lives. Globally, older people represent a rapidly increasing percentage of the population and people are living much longer. For the first time in the world's history there will be more people over the age of 60 than under the age of 5 by 2045. In Ireland the number of people aged 65 and over is projected to rise from approximately 700,000 to 1.89 million by 2041. The Department of Health notes that by the year 2021, the number of older people living in the State is expected to increase by 55 per cent. In Leitrim, the 2011 Census revealed that 15 per cent of the population were aged 65 or over and that 33 per cent were aged 50 or over. In the context of these figures, it is timely to consider a strategy for meeting the changing needs of the population in Leitrim as we grow older and to ensure that a multiagency approach leads to the best use of the available resources in these economically challenging times.

The World Health Organisation has been carrying out important work in this area through its 'Age Friendly Cities' programme. This programme is part of an international effort to address environmental and social factors that contribute to active and healthy ageing. The programme helps cities and communities to become more supportive of older people by addressing their needs across eight themes:

- Outdoor Space and Buildings
- Transport
- Housing
- Social Participation



- Respect and Social Inclusion
- Civic Participation and Employment
- Communication
- Community Support and Health Services.

In Leitrim we recognise the challenges that lie ahead, that the age profile of the population is growing year on year and that this places a greater demand on a range of services. The expectations of the people who are living longer are rising too and rightly so. People want to live independent fulfilling lives. They expect to participate fully in the life of the community. We choose to see the changing social reality as an opportunity to build a more inclusive society. Older people are a resource for their communities and their inclusion will enrich the quality of community life.

Age Friendly work is taking place in many parts of Ireland. Nationally, the Age Friendly Cities and Counties Programme is being supported by the Age Friendly Ireland. Regionally, Leitrim is linking with and learning from the experience of counties like Louth, which has been a pioneer nationally of much innovative and good practice. It has also benefitted from links with Meath, Fingal and with neighbouring counties, Cavan and Monaghan.

### **National Policy Context**

There are various policy documents of relevance to this area of work. Key among them is the National Positive Ageing Strategy which was published by the Department of Health in 2013. The Strategy will provide the blueprint for planning for an ageing population in Ireland into the future.

Another key policy document is the National Action Plan for Social Inclusion (2007-2016) 'Building an Inclusive Society', which is structured around a lifecycle framework with older people as a core category and which contains high level goals regarding community care and income support.





A futher pertinent policy document is the National Carers Strategy (2012). Numerous other health related policies are also relevant, among them the National Policy on Elder Abuse arising from the Report of the Working Group on Elder Abuse, Protecting Our Future (2002) and the 2009 review of that report, the Nursing Home Support Scheme and Fair Deal introduced in the Nursing Home Support Scheme Act 2009, and the standards, regulation and inspection of nursing homes introduced in the Health Act 2007.

### **Outcomes Based Planning**

The County Leitrim Age Friendly Alliance's focus is to ensure that this strategy brings tangible and measureable improvements for older people. The targets that have been set and the actions that will be undertaken have been developed by using an outcomes-based planning approach based on the framework developed by the Ageing Well Network, which was the original initiator of the Age Friendly Towns and Counties Programme, which in turn has led to the development of Age Friendly Ireland.

The starting point for this approach is the change that we aim to bring about. This approach focuses on the goal that we are hoping to achieve and then we work back from there to identify the actions, which will best help us to achieve the results that we seek. By beginning the planning process by focusing on broad outcomes, it quickly became clear that no single agency could bring about these outcomes, but that progress would require various agencies to contribute and work collaboratively in a creative way to improve the lives of older people. This approach therefore challenges the 'silo' approach to planning which limits agencies to focusing solely on what they see as their core roles and responsibilities rather than appreciating how they can contribute in a broader holistic way to the achievement of a range of outcomes.

The Alliance has introduced a further refinement to this approach by seeking to identify cross-cutting themes and issues and actions that facilitate an inter-agency approach, which enables the agencies to add value to each other's efforts. Rather than re-state the range of measures that each agency undertakes to meet the needs of older people, the strategy concentrates on identifying innovation and creative and cost effective inter-agency actions and approaches to meeting the needs and facilitating the participation of older people.

The methodology adopted by the Alliance places the needs of older adults right at the core of the planning process and ensures that their views, opinions and experiences have shaped the strategy. This approach will also allow the Alliance to measure its progress by reviewing whether the actions are bringing about the intended outcomes. In this way it will be able to demonstrate progress in implementing its action plan - to show that it is 'making a difference'- by tracking the achievement of these indicators over the lifetime of the strategy. This is an increasingly important consideration as resources have become scarcer and there is a more pressing need to account for their effective use.



### Outcomes for older people in this context will mean that they:

- 1. Are valued as individuals for their unique life experiences and have meaningful opportunities to shape and enhance the communities in which they live;
- 2. Have opportunities for civic, social and economic participation and life-long learning;
- Are supported to stay living in their own homes and connected to their communities;
- 4. Lead healthier and active lives for longer;
- 5. Are able to get to where they want to go, when they want to go;
- 6. Live in places where the social and physical environments are conducive to being out and about;
- 7. Feel and are safe in their own homes and their communities;
- 8. Have the required information and communications to support them achieve these outcomes.

### Implementation and Monitoring

The designated Lead Partners will be responsible for leading the implementation of each of the actions outlined in the strategy. The County Leitrim Age Friendly County Alliance Board will meet regularly to monitor and review progress on all of the actions and to consider amendments and refinements to the strategy in response to changing circumstances and stakeholder feedback. It will review both the outputs and outcomes of the implementation of the strategic actions. The Board is supported by an Executive Group, which has representation from a number of the Alliance Partners. This Group will be tasked with co-ordinating and overseeing the operational roll out of the strategy. Part of its brief will be to liaise closely with the Older People's Council to elicit regular feedback from older people in the county regarding the delivery of the strategy, thus creating an important stakeholder feedback loop that will be crucial to its ongoing implementation and monitoring.



## Theme

### Outdoor Spaces and Buildings "There are a lot of go county but payements

"There are a lot of good facilities in the county but pavements need to be level and smooth and signage could be improved."

### Action 1.1 - Age Friendly Towns

### Issues Raised by Older People in the Consultation Process

People wish to stay in their own homes
Need for opportunities for older people to connect socially
Better Signage
Improved footpaths
More walkways
Need to repair roads and ensure even surfaces on walkways
Provision of public toilets and picnic parks

### **Proposed Action**

Linked to the process of reviewing the County Development Plan, Leitrim County Council will carry out pilot Age Friendly planning exercises in selected towns in the county. The objective of Age Friendly Towns is to significantly improve the quality of life of older adults living in those areas and to engage them in shaping and enhancing their own communities. The smaller scale of the Age Friendly Towns initiative allows real change and impact on the lives of older people and will provide evidence to demonstrate what can be done at a local level. The County Leitrim Age Friendly Alliance will apply to the Age Friendly Ireland hosted National Age Friendly Towns Programme, for an intern planner to help manage and coordinate the process in each of the towns targeted and to take part in a Learning Network. The intention is that the planners will create a final report, collaborating to complete a critique of the planning processes across all key agencies and documenting their experience of achieving improved outcomes through multi-agency cooperation.



These exercises will use information already gathered from Disability Audits and will involve Active Age groups, Disability groups and a range of community players in carrying out "Walkability Audits" and Council Planning and Engineering staff in carrying out public consultation to inform "Accessibility Development Plans" to underpin the Age Friendly Towns initiative.

• A Steering Group, with representation drawn from Alliance members and partners, will be developed to oversee the project.

 The Council will apply learning from the Age Friendly Towns Programme and access training for its planners and engineers on Age Friendly communities prior to the initiative commencing.

 The Council will aim to attain Age Friendly Town Charters (as benchmarked within the Age Friendly Towns and Counties programme) for the selected towns.
 It will also aim to include a recognition of best age friendly practice through the National Age Friendly Recognition Scheme.

 In the longer term it is envisaged that the process will be rolled out to other selected towns in the county

### Output

- Better integration of services including transport, restaurants, hotels, post-offices, banks, hairdressers.
- Shops and supermarkets that are 'age-friendly' with good signage, suitable noise levels, seating, managed queuing, adequate spaces for trolleys, price tags that can be read.
- Improved accessibility of streets and public realm in selected towns for people with limited mobility.
- Level pavements, free from obstruction to reduce the fear of falling and being tripped.
- Enhancement of parks for greater social and age friendly exercise opportunities.
- Buildings and public spaces are more accessible and age friendly.
- A more accessible environment.

### Action 1.2 – Age Friendly Buildings

### Issues Raised by Older People in the Consultation Process

Need to plan that services are positioned and designed to ensure easy access Need to improve access for wheelchairs

Older people specifically highlighted Carrigallen as a model of best practice and would like this model replicated across the County

### **Proposed Action**

The HSE will aim to retrospectively apply good practices to their current Day Care Centres and adopt Universal Design guidelines from the WHO Age Friendly Primary Care Centres Toolkit for proposed new public buildings, such as Primary Care Centres and Day Care Centres. This will provide a process for auditing how accessible buildings are to older people and encourage the use of universal design guidelines for new developments.

- This will encompass creating wider access to buildings and information on their use.
- Best practice can be shared with other agencies in a bid to ensure age friendliness across all buildings for older people.

### Output

- HSE in Leitrim will be the first in Ireland to utilise the WHO Framework and apply practices, such as audits, to enable them to make their Centres more accessible and age friendly.
- As learning is shared with other agencies, in the long-term public buildings throughout the county will become more accessible.

## Theme

### Transportation

"I love the social car scheme but it's a pity that it's not across the whole county."

### Action 2.1 – Rural Transport

### Issues Raised by Older People in the Consultation Process

Rural transport is prescriptive rather than on demand, does not link with other transport i.e. trains and national buses

Need for integration and mapping of existing transport services e.g. utilise school buses, rural transport etc.

Important for local groups to be empowered to have a say in service provision and to know how to lobby for services

### **Proposed Action**

Linked to the National Transport Authority, a regional joint venture company will be set up by the existing Rural Transportation providers in counties Leitrim, Roscommon and Sligo. This will be the Transportation Co-ordination Unit for these counties. Leitrim Development Company is one of the partners to the new company structure, which will be based in Carrick on Shannon.

- This arrangement means that there is no threat to any existing providers or transport services, encompassing a commitment (funding permitted) to continue to deliver existing rural transport routes and maintain passenger trips per month.
- All of these journeys will continue to be maintained on the National Journey Route Planner and the National Transport Authority website. Efforts will continue to shape the Regional Transport service so that Leitrim residents continue to benefit from this high level of service.





### Output

- Increase in frequency and volume of transport options available to older people.
- 53 rural transport routes operating in the county.
- Maintenance of 4,000 passenger trips per month (with a passenger profile of 83% older people) and one off on demand journeys.
- Greater availability of transport in rural parts of County Leitrim.
- Increase in number of older people being able to attend local events.

### **Proposed Action**

Leitrim Development Company will continue to provide a Social Car Scheme with 11 volunteer drivers in North Leitrim.

It will seek funding to extend the scheme to the entire county.

### Output

- Increase in frequency and volume of transport options and areas of coverage available to older people.
- Increase in number of journeys.
- Greater availability of transport in rural parts of County Leitrim.
- Increase in number of older people being able to attend local events.

## Theme

### Housing

"Support people to live as independently as possible in their own area. There could be more security for older people in their homes.."

### Action 3.1 – Support Independent Living

### Issues Raised by Older People in the Consultation Process

People wish to stay in their own homes and live independently with proper access to all services

Ensure good quality community based day care is available Need for opportunities for older people to connect socially

The various agencies need to work together to help older people to stay in their own homes

### **Proposed Action**

Leitrim County Council will work with a range of partners including voluntary housing associations to enhance the potential of older people to enjoy safe, healthy and independent living. It will continue to provide programmes such as Housing Adaptation Grants for Older People and People with a Disability based on assessed need within allocated resources.

 The Council will continue linking with the HSE, particularly regarding enhancing its prioritisation mechanisms, particularly where the condition of a house is delaying possible discharge from hospital.

HSE will continue to provide Home Help, Home Care Packages and Day Care Places based on assessed need within allocated resources. The aim is to promote optimal independence while supporting Older People to remain in their own home for as long as is practical.





### Output

- Applications for Housing Adaptation Grants for Older People and People with a Disability will be assessed in a timely fashion based on need within allocated resources.
- Fewer delays in discharge from hospitals for older people.
- Enhanced access for older people to health and social care services, which support independent living.

### Action 3.2 – Older People Feeling Safe in their Homes

### Issues Raised by Older People in the Consultation Process

We want to feel safe in our own homes and communities

We have a fear and anxiety of bogus callers and tradesmen - provide list of reputable tradesmen to increase confidence for older people

We like the Care and Repair Service but want to see more of it

Would like more security lighting in our homes and areas

Would like more fire safety information, fire extinguishers, fire escape ladders etc. Would like more FAS and CE schemes for community work





### **Proposed Action**

Leitrim Development Company will continue to deliver the Better Energy Warmer Homes Scheme, providing attic and cavity wall insulation and ventilation for houses built before 2006, to people entitled to claim Fuel Allowance, in receipt of Job Seekers Allowance for 6 months, with children under the age of 7, and Family Income Support.

- While funding is in place, the Development Company will continue to operate the Care and Repair scheme in North Leitrim as part of Age Action franchise, and continue trader referrals for older people.
- Leitrim Development Company in partnership with Leitrim County Council will
  continue to deliver a Joint Community Employment scheme targeted at Estate
  Management in Local Authority estates and enhance existing schemes where
  additional funding is available.
- Leitrim Development Company and Leitrim County Council will continue the joint roll out of installation of smoke alarms.
- The National Fall Prevention Strategy will be rolled out through local Primary Care and Local Community Day Hospitals.
- Raise awareness of existing fire safety information sessions in Day Care Centres.
- Leitrim Development Company and the Council will continue to jointly bid for projects, which target energy efficiency and meet the needs of older people.
- Leitrim Development Company will also continue to operate community programmes benefiting older people including Community Employment, Job Initiative, TUS and the Rural Social Scheme.

### Action 8.2 – Community Mental Health

### Issues Raised by Older People in the Consultation Process

There is a high suicide rate in the county There are a high number of older people living alone, who are socially isolated There are high incidences of depression amongst older people

### **Proposed Action**

Sligo Leitrim Mental Health Service is placing great emphasis on providing care pathways which are underpinned by a Recovery Philosophy of Care and are provided to individuals experiencing acute mental health difficulties in the least restrictive environment, with the minimum disruption to their lives. It is the Service's ambition that the majority of mental health service provision will be provided away from acute mental health centres and in service users' communities and localities, through Integrated Social Day Care Centres, home based treatment and assertive outreach models of care. This model of community-based care is supported by international literature and as a model is more accessible and facilitates full participation and integration of service users within the community (World Health Organisation; WHO, 2007). This integrated care will be provided to service users in their local community via the delivery of effective Multi Disciplinary Teams working within two Sector teams. These teams will be co-located within Primary care settings in Carrick on Shannon and Manorhamilton, which will provide even greater mental health care accessibility for members of the public.



A Vision for Change, recommends that integrated care is provided to service users in the context of their local community and that this is delivered primarily through Community Mental Health Teams (CMHTs), each of which typically caters for a population of 50,000. For CMHTs to be effective, it is vital that the vision and goals of community-based treatment are shared by the team and reflected in its development. Teams need clearly defined goals and robust governance structures as well as agreement regarding their model of clinical responsibility to be effective. The sector team should also agree flexible protocols for its clinical and operational practice, adapted to the needs of the populations it serves. Standards for service provision will be set by the Area Mental Health Management Team in conjunction with service users to ensure consistency and equity between both sector teams. In achieving this level of equity some fundamental principles and functions need to be accepted by all team members.
